MODE OF MEETING

In view of the COVID-19 outbreak and as part of the safety measures, the 44th Annual General Meeting ("AGM") will be conducted entirely through live streaming from the Broadcast Venue. This is line with the Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 18 April 2020.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act, 2016 which requires the Chairperson of the meeting to be present at the main venue of the meeting. Shareholders **WILL NOT BE ALLOWED** to attend the 44th AGM in person at the Broadcast Venue on the day of the meeting.

REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Shareholders are to attend, speak (including posing questions to the Board via real time submission of typed texts) and vote (collectively, "participate") remotely at the 44th AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at https://tiih.online.

Shareholders who appoint proxies to participate via RPV in the 44th AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **Tuesday, 16 June 2020 at 11.30 a.m.**

Corporate representatives of corporate members must deposit their original certificate of appointment of corporate representative to Tricor not later than **Tuesday**, **16 June 2020 at 11.30 a.m.** to participate via RPV in the 44th AGM.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor not later than **Tuesday**, **16 June 2020 at 11.30 a.m.** to participate via RPV in the AGM.

A shareholder who has appointed a proxy or attorney or authorised representative to attend, participate, speak and vote at this Annual General Meeting via RPV must request his/her proxy to register himself/herself for RPV at TIIH Online website at https://tiih.online

PROCEDURES FOR RPV

Shareholders/proxies/corporate representatives/attorneys who wish to participate the 44th AGM remotely using the RPV are to follow the requirements and procedures as summarized below:

(a)	Register as a user with TIIH Online	 Using your computer, access the website at https://tiih.online. Register as a user under the "e-Services". Refer to the tutorial guide posted on the homepage for assistance. If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online. 			
(b)	Submit your request	 Registration is open from 11.30 a.m. Monday, 18 May 2020 up to 11.30 a.m. Tuesday, 16 June 2020. Login with your user ID and password and select the corporate event: "(REGISTRATION) SCIB 44th AGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select "Register for Remote Participation and Voting" Review your registration and proceed to register System will send an e-mail to notify that your registration for remote participation is received and will be verified. After verification of your registration against the General Meeting Record of Depositors as at 10 June 2020, the system will send you an e-mail to approve or reject your registration for remote participation.

(c)	Login to TIIH Online	Login with your user ID and password for remote participation at the 44 th AGM at any time from 11.10 a.m. i.e. 20 minutes before the commencement of the AGM on Thursday , 18 June 2020 at 11.30 a.m. .			
(d)	Participate through Live Streaming	 Select the corporate event: "(LIVE STREAM MEETING) SCIB 44TH AGM" to engage in the proceedings of the 44th AGM remotely. If you have any question for the Chairperson/ Board, you may use the query box to transmit your question. The Chairperson/ Board will endeavor to respond to questions submitted by remote 			

		participants during the 44 th AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.
(e)	Online Remote Voting	 Voting session commences from 12.00 p.m. on Thursday, 18 June 2020 until a time when the Chairperson announces the completion of the voting session of the 44th AGM. Select the corporate event: "(REMOTE VOTING) SCIB 44th AGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
(f)	End of remote participation	• Upon the announcement by the Chairperson on the closure of the 44 th AGM, the live streaming will end.

Note to users of the RPV facilities:

- 1. Should your application to join the meeting be approved we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

 Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide your vote.
 Review and confirm your proxy(s) appointment.
Print proxy form for your record.
